

## Section 8 NGO Objects

- To support farmers and laborers by providing modern agricultural techniques, sustainable farming training, safe working conditions, and skill development programs.
- To empower youth and women through career guidance, vocational training, entrepreneurship support, leadership programs, and self-help groups for economic independence.
- To promote skill development and employment by providing vocational training, entrepreneurial opportunities, and organizing examinations, skill tests, and competitions across various fields.
- To address gender-based challenges through awareness campaigns, legal support, advocacy for equal rights and opportunities for women, and promoting gender equality in education.
- To protect children and prevent child labor by raising awareness, ensuring education, enforcing child protection laws, preventing
